ORDINANCE NO. _____

An Ordinance to amend Title 2, “General Government”, Chapter 3, “Municipal Organization”, Section 1, “City departments and offices”, to establish a new department, the “Communications Department”.

SECTION 1.

BE IT ORDAINED by the Council of the City of Birmingham that Title 2, “General Government”, Chapter 3, “Municipal Organization”, Section 1, “City departments and offices”, be and is hereby amended to establish a new department, the “Communications Department” and to read as follows:

“Sec. 2-3-1. - City departments and offices.

The following departments and offices of the city are hereby established:

- (1) Arlington;
- (2) Alabama State Fairground;
- (3) Boutwell Auditorium;
- (4) City clerk;
- (5) City council;
- (6) Community development;
- (7) Equipment management;
- (8) Finance department;
- (9) Fire department;
- (10) Human resources;
- (11) Information management services;
- (12) The Office of the City Attorney;



- (13) Mayor's office;
- (14) Municipal court;
- (15) Museum of Art;
- (16) Planning, engineering and permits;
- (17) Police department;
- (18) Public works;
- (19) Sloss furnaces;
- (20) Southern Museum of Flight;
- (21) Department of Transportation;
- (22) Department of Innovation and Economic Opportunity
- (23) Communications.”

SECTION 2. That the provisions of this Ordinance are hereby declared to be severable. If any of these sections, provisions, sentences, clauses phrases, or parts are held to be unconstitutional or void, the remainder shall continue in full force and effect.

SECTION 3. That this Ordinance shall become effective upon publication as required by law.
