Request for Review of Property ----- Artemus Willis

Item 1: A request for the Public Improvement Committee to review property that has 1 voided repair permits. **204 Graymont Avenue.** On July 7, 2020, **Mr. Christopher Brown, 1129 47th Street Ensley, Birmingham, AL, 35208,** submitted an application for a Special Repair Permit. This property was condemned by City Council on December 1, 2015.

Item 2: A request for the Public Improvement Committee to review property that has 4 voided repair permits. **210 Graymont Avenue.** On July 7, 2020, **Mr. Christopher Brown, 1129 47th Street Ensley, Birmingham, AL, 35208,** submitted an application for a Special Repair Permit. This property was condemned by City Council on October 9, 2007.

Item 3: A request for the Public Improvement Committee to review property that has 4 voided repair permits. **214 Graymont Avenue.** On July 7, 2020, **Mr. Christopher Brown, 1129 47th Street Ensley, Birmingham, AL, 35208,** submitted an application for a Special Repair Permit. This property was condemned by City Council on April 23, 2007.

Item 4: A request for the Public Improvement Committee to review property that has 4 voided repair permits. **119 9th Avenue West.** On July 7, 2020, **Mr. Christopher Brown, 1129 47th Street Ensley, Birmingham, AL, 35208,** submitted an application for a Special Repair Permit. This property was condemned by City Council on October 9, 2007.

Item 5: A request for the Public Improvement Committee to review property that has 0 voided repair permits. **6514 6th Avenue South.** On July 14, 2020, **Mr. Charlie Preyer, 6514 6th Avenue South Birmingham, AL, 35212,** submitted an application for a Special Repair Permit. This property was condemned by City Council on August 27, 2019.

On August 3, 2020, **Ms. Camille Dykes, 5883 Foxfield Trail Rex, GA, 30273**, submitted an application for a Special Repair Permit. This property was condemned by City Council on November 28, 2017.
