### VI. AMENDMENT TO CITY CODE: PUBLIC SPACE PERMIT: ATTORNEY JULIE BARNARD, OFFIE OF THE CITY ATTORNEY

The Amendment is to combine the Outdoor Cafe Permit and the Shared Space Permit into one.

The application process and enforcement will be managed by Birmingham Department of Transportation (BDOT).

There will be an annual fee accompanied by an annual inspection.

The permitting process will be strictly controlled by the Administration and will not come before Council committees unless an applicant appeals a decision by the Administration.

If a business is not in compliance, thy will receive a visit from BDOT and a letter giving them notice of 30 days to meet compliance guidelines. If this period passes with no change, the owner will receive a summons for Municipal Court.

The City of Birmingham is allowing a revocable license holder to use the Right of Way so the City can send a Cease and Desist Letter.
