**11.** Memorandum of Understanding and Intergovernmental Agreement with The Board of Trustees of The University of Alabama for The University of Alabama Hospital, under which the City of Birmingham Fire and Rescue Service will provide certain in-home follow-up care and treatment to patients it transports to University Hospital after hospital discharge, to include certain medical interventions, preventive care, and the identification of new medical conditions, and University Hospital will pay the City \$195.00 per patient per month for each patient participating in this Paramedicine/EMT Program.
