#### B. FIRST AMENDMENT TO DEVELOPMENT AND LEASE AGREEMENTS

1. Downtown Jimmie Hale Mission

#### Jim Stanlev:

The first item concerns parallel amendments to the lease and development agreements with the Jimmy Hale Mission. The City owns the old Thomas School property located on 2<sup>nd</sup> Avenue North and leased it to Jimmy Hale Mission. The lease was for a term of 40 years and provided that at the end of the term, Jimmy Hale Mission would purchase the property. The Jimmy Hale Mission could buy it for \$100.00 and agree to continue with restrictive covenant to use it for their services or they could pay market value and take it free and clear. This Mission has said they would go ahead and move on the purchase of the property. They are willing to take title with the restrictions, because they do plan to continue to use it. These are amendments to the development agreement, corresponding limit to the lease agreement that

allow them to proceed with the purchase of the property, subject to that restriction.
