Memorandum of a Right-of-Way Use Agreement -----Albert Jackson

Item 1: Right of Way Encroachment License Agreement between the City of Birmingham and Aptitude Birmingham, LLC, regarding the proposed installation of brick pavers, sidewalks, ornamental lights, tree planters, stop signs, ADA parking stalls, crosswalks, updated traffic signals, storm drain connection, sanitary sewer connection and paving, for the purpose of student housing located at 302-13th Street, South.

Item 2: Right of Way Encroachment License Agreement between the City of Birmingham and The Hardwick, LLC, regarding the proposed installation of a grease trap, doors, wooden benches, awnings, bike racks, planters, and a monument sign, for the purpose of the redevelopment of the Hardwick Building, located at 2308 – 1st Avenue, South. The fixtures will encroach into, over and upon the rights of way of Powell Avenue, 23rd Street, South and 1st Avenue.

Item 3: Right of Way Encroachment License Agreement between the City of Birmingham and Cool Hand Holdings, LLC, regarding the proposed installation of one (1) blade sign, for the purpose of a leased-out office space. The sign will project from exterior of building located at 2421 – 2nd Avenue, North.

Item 4: Right of Way Encroachment License Agreement between the City of Birmingham and Urban Beverage 2, Inc. regarding the proposed installation of one (1) blade sign, for the purpose of a local cocktail bar. The sign will project from exterior of building located at 2218 – 1st Avenue, North.

Item 5: Right of Way Encroachment License Agreement between the City of Birmingham and Birmingham Properties I Owner, LLC, regarding the proposed placement of two (2) dumpsters

for the purpose of trash pick-up. The dumpsters will be placed along the exterior of the building located at 1300 Powell Avenue, as shown on the attached.

Item 8: A Resolution approving and authorizing the Mayor to execute and deliver an Interlocal Cooperation Agreement between **ALABAMA DEPARTMENT OF CORRECTIONS** ("Institution" or "ADOC") and the City of Birmingham to provide workers to assist in the provision of general services, in light of severe worker shortages and retention challenges. The ADOC has within its custody certain inmates who can provide the services required by the City to advance the City's neighborhood revitalization goals. The City and ADOC are dedicated to improving the quality of life for inmates in ADOC custody, and formerly incarcerated individuals, one of the City's most challenged communities. In consideration of providing the inmates to the City, the City shall pay the ADOC twenty dollars (\$20.00) per inmate, per day.
