V. BDOT UPDATE

Presented by: Colin Alexander, BDOT

Colin Alexander presented an update.

Paving

The Council voted to accept Dunn Construction's bid for local resurfacing (slightly over \$12 million).

Construction should begin at the end of February or early March, and will continue through out the year.

It includes approximately 250 street segments/approximately 40 miles of streets to be resurfaced. There will be 15 complete street segments that will be striped as part of the project. To project also includes minor sidewalk repairs, ADA ramps, etc.

In addition to the local package, there are two grant packages that the department has been working on.

The ALDOT Funded Package – construction to begin late spring early summer.

NPO Funded Package – includes Springfield Road – work should begin the summer 2023 with construction later in the year.

The paving portion of Jefferson Avenue is completed. The striping is not completed.

The Pavement Management Program RFP should be published by the end of January 2023, and a contractor should be secured by February 2023.

Section-130 Rail Safety Grant

The BDOT received a Section-130 Rail Safety Grant from the Department of Transportation.

BDOT partnered with Norfolk Southern, who paid the 10% match to install quick curb safety bollards.

Bollards have been installed at Russell Avenue, 15th Place SW and 17th Street SW.

Sidewalk Project Update

The Marino's sidewalk project is the pre-construction phase. Construction should begin the week of January 23, 2023.

Traffic Calming

The speed cushions on 10th Court West will be installed in January 2023.

Additional speed cushions (bulk order) have been ordered.

An additional speed cushion will be installed on Glenwood Street.
