3. ALABAMA DIGITAL EXPANSION TEAM – ANETA LEE, FUSE EXECUTIVE FELLOW Aneta Lee presented information to the Committee.

ADECA is hosting a technical assistance program kick-off meeting, January 23, 2023, 9:00a – 2:00p at the Regional Planning Commission of Greater Birmingham (County Office).

The technical assistant program will prepare the County and State to receive infrastructure funding.

They will engage more with elected officials and community members.

A phone survey will be launched/incorporated.

Broadband asset mapping, funding and countywide analysis will be included.

The technical assistance timeline is January through March 2023.

The broadband deployment fund is part of the \$1.2 trillion infrastructure bill from 2021.

A broadband mapping will determine to amount of funding the State will receive.

Each state received BEAD five-year planning funds and has one year to come up with a digital equity plan. The State of Alabama received its five-year planning funding on December 19, 2022 (close to \$6 million).

The timeline for funding is very intentional for covered population.

Ms. Lee is recommending that the City of Birmingham invest in a digital equity officer as well as in small internet infrastructure project.

MINUTES

FY 2023 Capital Budget – Current System Assets

The 2023 Capital Budget totals \$72,307,526

- \$18,000,000.00 for general capital, technology, and distribution projects. This includes to funding to explore automated meter reading.
- \$18,269,100.00 for maintenance and repair projects.
- \$25,000,000.00 for distribution main replacement program
- \$11,038,426.00 for capitalized O&M.

BWWB has received rewards for quality/safe water

BWWB has a 3.9% rate increase for FY2023.

There has been an increase of \$12.3 million in delinquent accounts since January 2022 (\$4.4 million in water and \$7.9 million in sewer).

BWWB is resuming disconnect services, but will only disconnect water as a last resort.

Three, six and twelve months installment plans have been implemented for customers who need assistance with bill pay.

BWWB is fully staffed with meter readers, and bill editing departments.

99% of customers are receiving timely bills.

Customers' credits are currently being posted to account.

Customers' refunds are currently being processed and mailed.

BWWB is back to normal operations.

The phone hours have been extended from 7:00a - 7:00p. The lobby is open 8:00a - 12:00p on Saturdays.
