- The expected construction start date is May 2023.
- The project cost is approximately \$2.6 million.

Richards Arrington Streetscape

- There is a supplemental plan with ALDOT
- The letting is scheduled for November.
- The construction is should begin early 2024.

41st Street

- Working through the utility coordination and final plans of acquiring the right-of-way, which is mostly temporary construction easements.
- The letting is scheduled for end of September.
- Construction should begin in late 2023.

Funds were also restored for the following projects.

- Greenspring Streetscape Phase II
- 19th Street Ensley
- 16th Street Corridor Streetscape
- Norwood 12th Avenue North Streetscape
- FL Shuttlesworth Drive Streetscapes

Traffic Calming Update

There are 30 open cases that have gotten to the stage where the petition has been signed in order to install speed cushions. The roads are eligible for the speed cushions.

- · Cresthill Road has been installed.
- 10th Court West is currently being installed.
- Funds have been transferred for five locations.
- Awaiting neighborhood votes for three locations.
- The project cannot move forward without buy-in from the neighborhood block.
- There have been issues with orders that have been placed for the speed cushions.
