# IV. Birmingham Parking Authority (BPA) Update

# Presented by: Andre Davis, Executive Director & CEO

Andre Davis presented an update to the Committee.

The BPA currently operates three (3) surface lots and seven (7) parking decks.

BPA's top priorities are:

- **Support Economic Development** support the growth and revitalization of Downtown Birmingham by serving growth areas, offices, commuters, residents, and events.
- Create a Unified and High-quality Parking Experience create a quality customer experience across all parking facilities (off-street, on-street, private) and serve as the first choice for parking in Birmingham.
- **Leverage Technology and Innovation** enhance technology to develop an efficient parking system that is easy to use and increases customer satisfaction and awareness of parking availability.
- Enhance Safety and Security lighting, cameras, monitoring systems, physical security and staffing.
- **Maintenance** ensure a sound preventive maintenance plan and equipment upgrades and reinvest into the facilities.

**Administration and Human Resources** – modernize the way things are done at the BPA. Make sure to have adequate staffing, trained and qualified to do the job.

# **Current Projects:**

- Conditions Assessment
- Administrative and Operational
- Process improvements and planning
- Establish benchmarks.
- American Airlines has added a flight to LaGuardia Airport.
- There are 53 departures from BHM on a weekly basis, over 39,161 seats available to passengers.
- BHM is working on direct flights to LAX and Austin, TX.

- There has been an increase in passenger traffic for 2023: January up 17%, February up 13%, March up 12% and April up 13%.

# Birmingham Airport Authority (BAA) Update Presented by: Ron Mathieu, President & CEO

Ron Mathieu presented an update.

The airport is an economic generator for the community.

The Airport does not receive local or state tax dollars for the operations of the airport.

The Federal Aviation Administration requires airports to be self-sufficient.

#### BHM's Economic Impact Includes:

The Airport has generated approximately \$1.6 billion in annual impact to the community:

- \$68,491,451 in direct economic impact
- \$436,147,730 in tourist spending
- \$378,479,386 induced
- \$478,269,839 in related industries
- \$198,181,211 in general expenditures

#### **Employment Impact:**

18,700 jobs, including 1,751 direct, 3,838 related to tours and 5,579 in related industries.

- The Airport has partnered with Global Giant Kuehne+Nagel (a six-year deal).
- Kuehne+Nagal will bring in the large 747 twice per week with cargo.
- BHM welcomed the first flight from Stuttgart, Germany in April 2023.
- International flights are arriving two times per week.

#### **New Capital Investments - \$85 million**

- New Air Cargo Facility \$28 Million
- Million Air Birmingham \$32 Million
- New Westside FBO (Fixed Base Operator) (Atlantic) \$25 Million

The Airport Board has approved a \$38 million cargo facility.

BJCTA has moved with several expansion during the past six months.

There is currently a promotion for 2 free rides for new riders.

Birmingham On Demand is covering the new area for discontinued fixed-route services (#12, #18 and #43 Max routes).

- **Eastside** expansion happened in November 2022.
- Downtown Late Night Hours expansion happened in December 2022.
- Ridership continues to grow.
- Continued ridership growth and media attention demonstrate the popularity and innovation of Birmingham on Demand.
- Service is available until 11:00 p.m. in the expanded areas.
