The Amendment No. 0004 incorporates and ratifies previously proposed Amendments to the Equipment Schedule (Amendment No 0002 and Amendment No. 0003) and further amends the Equipment Schedule and Service coverage. The total annual costs for the remainder of the lease/purchase agreement shall not exceed Eight Hundred Seventy Thousand Forty and 65/100 Dollars (\$870,040.65). The total amount to be paid by the City pursuant to this Agreement shall be increased from Five Million One Hundred Thousand and 00/100 Dollars (\$5,100,000.00) to a total which shall not exceed Seven Million Six Hundred Twenty Thousand Two Hundred Eighty-four and 55/100 Dollars (\$7,620,284.55).
